Dear Mr Briody,

Thank you very much for your letter of 11 April 2010 addressed to Mr Jonathan Faull. I have been asked to reply to you.

I have read with interest your detailed analysis and the critical conclusions on different aspects of Germany's judiciary in general, and in particular on the German family court system. However, I regret to inform you that the European Commission has no competence to intervene either in the organisation of the justice system or the day-to-day business of the judiciary of any individual Member State. The powers of the European Union and the Commission in the field of justice and security derive from the Treaties on European Union, providing that Member States themselves are responsible for the maintenance of law and order in their country.

If I understood you correctly, personally you are not affected by the situation you describe. However, if someone believes that they are a victim of a violation of the European Convention for the Protection of Human Rights and Fundamental Freedoms, they should contact the European Court of Human Rights directly. Doing so, they must bear in mind that one can bring an action in that Court only after all the domestic remedies available have been exhausted; and they must do so within six months of the domestic decision becoming definitive.

Subject: Complaint about the Quality of Family Courts in Germany

Dear Director General Faull,

allow me to introduce myself. As an ex-RAF officer, I have been resident in Germany since 1979. I am not personally affected by what I am going to tell you, so I that I can reasonably lay claim to neutrality.

I had learned in the RAF, in various functions at courts martial and boards of inquiry, to assess a process by its procedures, formalities and quality. These techniques, applied to German family courts, lead to the conclusion that these are "unfit for European cooperation". As there is an impact on EC Regulation 2201/2003, I decided to formulate the attached complaint, which also recommends Germany's suspension from the agreement until satisfactory standards can be introduced.
